

On some issues of the Ministry of finance of the Republic of Kazakhstan

Decree of the Government of the Republic of Kazakhstan from 24 April 2008
#387

Collected Acts of the President and the Government of the Republic of
Kazakhstan, 2008, # 22, art. 205

The Government of the Republic of Kazakhstan **RESOLVES**:

1. To confirm the applied:

1) Provision about the Ministry of Finance of the Republic of Kazakhstan;

2) list of the organizations which are in the jurisdiction of the Ministry of Finance of the Republic of Kazakhstan;

3) changes which are introduced in some decisions of the Government of the Republic of Kazakhstan.

2. To form the Committee on financial monitoring of the Ministry of Finance of the Republic of Kazakhstan.

3. To create official institution, i.e. the territorial body of the Committee on financial monitoring of the Ministry of Finance of the Republic of Kazakhstan, the Department on financial monitoring of Almaty city.

4. To reorganize:

1) official institutions - territorial bodies of the Committee of the state property and privatization of the Ministry of Finance of the Republic of Kazakhstan in official institutions - inter-regional departments of the Committee of the state property and privatization of the Ministry of Finance of the Republic of Kazakhstan according to the annex 1 to the present resolution;

2) official institutions - territorial bodies of the Committee on work with insolvent debtors of the Ministry of Finance of the Republic of Kazakhstan in official institutions - inter-regional departments of the Committee on work with insolvent debtors of the Ministry of Finance of the Republic of Kazakhstan according to the annex 2 to the present resolution.

5. To rename:

1) Committee of the financial control and public procurement of the Ministry of Finance of the Republic of Kazakhstan in Committee of financial control of the Ministry of Finance of the Republic of Kazakhstan;

2) official institutions - territorial bodies of Tax committee of the Ministry of Finance of the Republic of Kazakhstan according to the annex 3 to the present resolution;

3) official institutions - territorial departments of the Committee of financial control and public procurement of the Ministry of Finance of the Republic of Kazakhstan according to the annex 4 to the present resolution;

4) official institutions - territorial bodies of the Treasury Committee of the Ministry of Finance of the Republic of Kazakhstan according to the annex 5 to the present resolution.

5-1. To ratify:

1) the List of official institutions - territorial bodies of Tax committee of the Ministry of Finance of the Republic of Kazakhstan;

2) the List of official institutions - territorial inspections of the Committee of financial control of the Ministry of Finance of the Republic of Kazakhstan;

3) the List of official institutions - territorial bodies of the Treasury Committee of the Ministry of Finance of the Republic of Kazakhstan;

4) the List of official institutions - inter-regional departments of the state property and privatization of the Committee of state property and privatization of the Ministry of Finance of the Republic of Kazakhstan;

5) the List of official institutions - inter-regional departments of the Committee on work with insolvent debtors of the Ministry of Finance of the Republic of Kazakhstan;

6) the List of official institutions - territorial bodies of the Committee of customs control of the Ministry of Finance of the Republic of Kazakhstan.

Footnote. The resolution is supplemented by item 5-1 according to the decree of the Government of RK from 03/20/2009 # 374.

6. To abolish official institution - territorial body of Tax committee of the Ministry of Finance of the Republic of Kazakhstan "Inter-regional tax committee # of 1 Tax committee of the Ministry of Finance of the Republic of Kazakhstan".

7. To define that powers on management of the property, which has remained after abolishment of the official institution specified in item 6 of the present resolution, are transferred to Tax committee of the Ministry of Finance of the Republic of Kazakhstan.

8. To consider some decisions of the Government of the Republic of Kazakhstan to have lost force according to the annex 6 to the present resolution.

9. To the Ministry of Finance of the Republic of Kazakhstan in accordance with the procedure established by legislation to take the measures following from the present resolution.

10. The present resolution comes into force from the date of signing, except for items 2, 4, 5, 6, 8, 13, 15 of the changes, which are introduced in some decisions of the Government of the Republic of Kazakhstan, confirmed by the present resolution, and also items 3, 4, 5, 8, 10, 11, 13, 14, 15, 16, 18, 19, 20, 22 of the annex 6 to the present resolution, which come into force after ten calendar days from the date of signing of the present resolution.
